Terms of Sale

4. Payment and Transactions

All transactions related to the purchase or sale of Crumoney tokens are recorded on the Ethereum blockchain. Due to the decentralized nature of blockchain technology:

- **Irreversibility**: Once a transaction has been confirmed on the blockchain, it cannot be reversed or canceled.
- **Fees**: Blockchain transactions may be subject to fees such as Ethereum network (gas) fees, which are not controlled by Crumoney.
